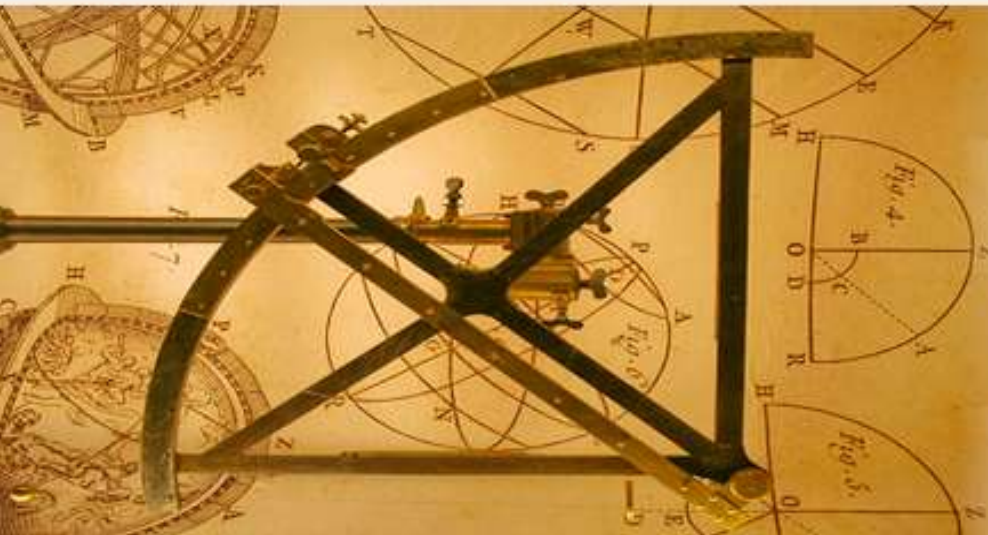

The client is assisted, inter alia, in any controversy referring to:

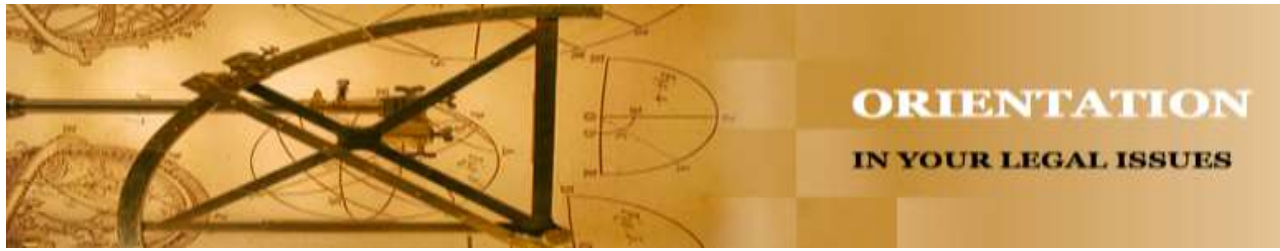
